Persons wishing to acquire Citizenship of St. Vincent and the Grenadines are required to:

- Complete Citizenship Application Form (including Reference page) and submit to the Office of the Prime Minister, along with:
- i. A *certified* passport-size photo of both *applicant* and *spouse*.
- Birth Certificate of both applicant and spouse and copy of passport bio-data page for both applicant and spouse. :::
- iii. Marriage Certificate.
- iv. Medical Certificate (of applicant).
- v. Police Certificate (of applicant).
- vi. Any other supporting documents, where applicable.
- 2. Pay an application fee of EC\$200.00. (non-refundable).
- Pay Registration fee of \$2,000.00/\$3,000.00 (payable on approval of the application). n
